Pursuant to the Regulation 30 (read with Part A of Schedule III) and other applicable provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, ("Listing Regulations"), we wish to inform you that, the Office of the Registrar of Companies, Mumbai, Maharashtra ("**ROC**") has issued an Order dated 31<sup>st</sup> January, 2025 under Section 137 of the Companies Act, 2013 imposing penalty of ₹ 3,61,000 (₹ Three Lakh Sixty One Thousand Only) on Sharon Bio-Medicine Limited("**Sharon**") (**a material subsidiary of the Company**).

The stated penalty pertains to default in filing of Financial Statements for the **Financial year 2018-19**. This non-compliance occurred prior to acquisition of Sharon by the Company and during a period when the Sharon was under CIRP process. The Company formally acquired Sharon on 30<sup>th</sup> June 2023.

Further, the penalty amount is not material from the perspective of both Company and Sharon. Sharon intends to file appropriate appeal against the said Order within the prescribed timelines before the Adjudicating Authority.
